

REGULATIONS OF RENTING A BICYCLE AT HOTELIK GOŁDAP

1. The following regulations contain rules for use, conditions, scope of rights and responsibilities of people using the bikes. Accepted rules become an Agreement between the Renter and Hotelik Gołdap.
2. Rented bikes are the property of Hotelik Gołdap.
3. Bicycles are equipped with a cable lock with a key, rear and front position lights, a bell, fenders and are specific labels.
4. In order to rent a bike, you must:
 - ◆ be the hotel's guest for at least a day,
 - ◆ sign a bike rental card with a declaration of knowing these Regulations, accepting their content and the acquisition of a fully operational bike,
 - ◆ be at least 13 and present the bicycle driving license if you are an unaccompanied minor,
 - ◆ not be under the influence of alcohol and other drugs, psychotropic substances or other similar substances according to the regulations on preventing drug addiction; other drugs that, by definition, prohibit, or recommend refraining from, driving.
5. The Renter agrees to:
 - ◆ use the bike and its accessories as intended,
 - ◆ return the bike with its accessories, fully operational and intact within a period of time consistent with the declared return,
 - ◆ use the bicycles only for noncommercial purposes and only for a personal use of a Renter,
 - ◆ comply with the ban on lending the bike to third parties,
 - ◆ not to use the bike to mountain hikes, jumps, stunts, tricks, racing, etc., and to use the bike to tow or push anything,
 - ◆ immediately report problems associated with the use of a bike to the hotel front desk employee, and withdraw the bike to the hotel in the event of any fault while cycling,
 - ◆ refrain from any self-repair, modification, replacement of parts in a rented bike,
 - ◆ cover the costs of repair of the damaged bike or its accessories resulting from the Renter's fault,
 - ◆ cover the cost of buying a new bike in the event of a total destruction of a rented bike.
6. In case of loss of the rented bike or its accessories as a result of circumstances for which a Renter is responsible, including a loss or theft, the Renter is required to pay the cost corresponding to the value of the bike and its accessories (based on the prices prevailing on the day of ascertaining the fact).
7. The Renter agrees to pay for all damages and penalties associated with the bike use arising from failure to comply with the laws in force in Poland, including the provisions of the Highway Code.

8. The Renter bears full responsibility for any accident or damage occurring during the bicycle rental. Being a participant of the road traffic, the Renter is obliged to follow the rules of road use, and does so it solely at his own risk. The user waives any claims against Hotelik Goldap for accidents, damages or injuries incurred during the period of the rental.
9. The Renter shall be solely responsible for any damage associated with the use of the rented bike, caused to third parties,
10. In case of renting bikes by an organized group, it is necessary to agree beforehand on the date and the number of bicycles with the front desk employee.
11. The Renter agrees to comply with the Regulations, in particular to make payments arising from the regulations of renting a bike from Hotelik Goldap, and use the bike according to the Regulations.
